- Installation and demo training to TCPC staff
- One-year post-installation service
- All machinery must be of branded, approved models

IV. Submission Guidelines

2. Other Instructions

- No overwriting/corrections unless duly signed and dated
- Quoted prices should include all costs: delivery, installation, commissioning, training, and applicable taxes
- Quotes not adhering to item specifications or format will be rejected

V. Eligibility Criteria

Financial Eligibility

- Average Annual Turnover (last 5 years): At least 50% of the estimated tender cost
- Positive Net Worth as of 31st March of previous FY
- No losses in more than two of the last five audited years

Technical Requirements

- Proven experience in similar supply and installation projects
- Authorization certificate for imported equipment (if applicable)
- After-sales support, warranty (min. 12 months), and AMC terms

VI. Responsibilities of the Bidder

- Supply branded machinery with relevant technical documentation
- Provide demo training post-installation
- Offer service support for at least 1-year post-commissioning
- Ensure all statutory and tax compliance (including GST and reverse charge mechanisms, if applicable)
- Submit required warranties, user manuals, and authorized dealership certificates

VII. GST & E-Invoice Compliance

Vendors must comply with all GST provisions including timely return filing, accurate invoice matching (GSTR-1 vs GSTR-2B), and e-invoicing (if applicable). Non-compliance may result in ITC loss recoveries from the vendor.

VIII. Terms of Payment

- Payment within 30 days of submission of original invoice post successful delivery, installation, and acceptance
- Invoice must include invoice number, GST details, bank info, signature, and company seal

IX. Dispute Resolution

- Disputes unresolved through negotiation will be referred to arbitration under the Arbitration and Conciliation Act, 1996
- Jurisdiction: Gandhinagar, Gujarat
- Language of Arbitration: English

X. Termination Clause

EDII reserves the right to terminate the contract:

- For delay or unsatisfactory services with 15 days' notice
- At any time with 1-month notice without assigning a reason
- If the agency terminates, 1-month written notice with reasons is required

XI. Other Terms & Conditions

- No subcontracting without prior approval
- No escalation in rates during contract duration
- Delivery must be completed within 5–6 weeks of supply order
- Penalty for delay: 0.5% of order value/day up to a max of 5%
- EDII reserves the right to reject any or all bids or award work to multiple agencies

XII. Proposal Ownership

All submitted documents and bids become the property of EDII and will not be returned. Bidders are responsible for their own costs related to bid preparation and submission.

Force Majeure

1. **Definition:**
"Force Majeure" refers to an event beyond the control of the selected Bidder, which is not due to the vendor's fault or negligence and is not foreseeable.
2. **Examples of Force Majeure** include but are not limited to:
 - Acts of God
 - Acts of public enemies
 - Acts of the Government of India in its sovereign capacity
 - War, fire, floods
 - Strikes and lockouts
 - Freight embargoes
3. **Obligation to Notify:** In the event of a Force Majeure situation, the selected Bidder must notify EDII in writing within **30 calendar days**, providing details of the condition and its cause.
4. **Extension of Time:**
 - The time for performance will be extended for a period **not less than the duration of the delay** caused by the Force Majeure event.
5. **Prolonged Delay:**

- If the delay continues beyond **three months**, EDII and the Bidder shall engage in consultations to find a mutually acceptable solution.

General Conditions

1. Once bids are opened and the contract is awarded, bidders must refrain from contacting the employer regarding their technical or financial bids.
2. Any attempt by a bidder to influence the evaluation, ranking, or contract award process will result in disqualification.
3. Bids received after the deadline will be rejected.
4. All costs related to bid preparation and submission shall be borne by the Bidder.
5. **Payment Terms:**
 - Payment will be made within one month after submission of the invoice.
 - Rates must be all-inclusive of GST.
 - A copy of the GST registration certificate must be submitted with the bid.
 - The invoice must include invoice number, date, GST number of both parties, GST bifurcation, signature, and company seal.
6. The Bidder is responsible for all taxes, duties, cess, and other charges under applicable laws.
7. No sub-contracting is allowed without prior written approval from the Institute. Unauthorized sub-contracting may lead to termination of the contract.
8. Contract rates shall remain firm for the entire contract duration. No rate revisions or price adjustments will be allowed.
9. The Bidder must sign all pages of the tender document as proof of having read and accepted the terms and conditions.
10. **Delivery Timeline:**
 - Delivery must be completed within 5–6 weeks from the date of the supply order.
 - Delayed delivery will attract a penalty of 0.5% of the order value per day, up to a maximum of 5%, unless an extension is obtained in writing.
11. The Employer shall not be liable for any loss arising due to reliance on the Tender Document by the Bidder.
12. Any tampering or modification of downloaded tender forms will lead to rejection and forfeiture of EMD/Bid Security.
13. Amendments or corrigenda to the tender will only be published on the official website and not in newspapers.
14. All expenses related to bid submission, including printing, postage, and delivery, are to be borne by the Bidder. EDII will not reimburse any such costs.
15. Bidders must conduct an independent assessment of site conditions, legal requirements, and project expectations.
16. Bidders are advised to regularly check EDII's website (<https://www.ediindia.org/the-institute/tenders/>) for updates at least 3 days prior to submission.
17. Only one tender per contractor (or related entity) will be accepted. Close relations or business partners cannot submit separate bids for the same contract.
18. No erasures or alterations in the tender documents will be permitted. Corrections must be clearly struck through, rewritten, and initialed.
19. **Tenders submitted via email will not be accepted.**
20. Any disputes arising out of the contract shall be referred to sole arbitration by a person appointed by the Director-General of EDII. The decision of the Arbitrator shall be final and binding.

21. EDII reserves the right to:
 - Reject any or all tenders without assigning reasons.
 - Award the work to more than one agency for expediency.
22. The Institute may terminate the contract by giving **one month's notice** if services are unsatisfactory. Similarly, the Agency may terminate the contract with one month's notice in writing, stating valid reasons.
23. All legal proceedings related to the contract shall fall under the jurisdiction of Gandhinagar, Gujarat.
